## Superintendent Position Announcement

The Superior Unified School District #15 consists of three schools serving 307 students in grades pre-K–12.

Located in southeastern Pinal County, 60 miles east of Phoenix, Arizona, the district extends from Florence Junction (west) to Top of the World (east) and covers approximately 265 square miles.

The Superior Unified School District (SUSD) is a Title I district. This designation provides additional funding to reinforce our reading and math foundations. It also allows our students to receive 100% free/reduced breakfast/lunch.

SUSD has partnered with the Vail Unified School District to implement the Arizona college- and career-ready standards in our K–12 classrooms through the Beyond Textbook curriculum guides and maps.

The district is also a member of the Cobre Valley Institute of Technology. CVIT assists the district in offering programs such as culinary arts, hospitality, welding, nursing, and fire science to our students.

In addition, we have built valued relationships with the Town of Superior, the Superior Chamber of Commerce, the Superior Rotary, the Superior Optimist Club, the Superior Little League, Boyce Thompson Arboretum, and Resolution Copper Mining Corporation. Resolution Copper has provided continued support for our athletics programs, nature club, hiking club, beyond textbooks, DECCA/FCCLA, and staff appreciation events.

Everyone at SUSD is dedicated to ensuring that our students receive daily high-quality instruction and have the materials and resources they need to succeed.

## Town of Superior, Arizona

Superior is nestled in a rugged, pristine mountainous setting within the Tonto National Forest, at an elevation of 2,882 feet, and is surrounded by peaks, including Iron Mountain at 6,056 feet. The Superior USD is proud to be a part of our town's rich history.

Superior was initially named Queen, then Hastings, and then finally platted under the name of Superior in 1900. Queen had a population of around 100 circa 1880. There was a general store, two hotels, numerous saloons, and a post office, which closed in 1881. The Superior town site was laid out in 1902 by George Lobb and named after the Lake Superior and Arizona Copper Company (LS&A). The Superior post office opened on December 29, 1902. By 1904, the town had many tents and a few primitive board houses.

Superior has experienced dramatic changes throughout its economic history. Its boom-and-bust cycles revolved around the mining industry, affecting everything from population and business growth to the underlying economy. This evolution even impacted how the community sees itself. Are we a mining town or a town with a mine?

Superior's recent history has seen the town develop into a much-loved sustainable community nestled in its beautiful high desert setting. The population has increased as people return to Superior. The community has become a draw for tourists interested in its long mining history, local architecture, the spectacular mountain scenery, and the preserved infrastructure of the Magma Mine. The population's diversity remains, and descendants of Superior's original settlers are proud of their ancestral heritage. To this day, the community retains its small-town cultural and historic charm.

Today, Superior, Arizona is in the midst of a renaissance - one that is being driven by long-time residents as well as newcomers and new business establishments who have come to Superior because of its small-town ambience and values, natural beauty and the promise of building a "new", vibrant community.
